

Sr. Personal Assistant, Level 7 of Pay Matrix	Candidates from Central/ State Govt., etc. in the following level are eligible for the post: i) Holding analogous posts on regular basis in their parent cadre/ Department Or ii) With 5 years regular service at the level of Senior Stenographer in Level 6 of Pay Matrix	-do-
